Public Questions and Comments:

David Osterbrink – Inquired on who was responsible to repair yard damage caused by the snow plows during this last winter as there are sections around the Village where there is significant damage. He also expressed that he hopes that the Board continues to work to support property values in the Village through enforcing building permit timelines and encouraging upkeep of properties.

Rezoning Request for Parcel ID Number 161-36-070301, 161-36-0705, 161-360702

Stolzenburg discussed the need for a new drain field at that site that would go into the Village right away and questions regarding how far the right away into the drain field. Stolzenberg asked for a proposed site plan in anticipation for an April 28th hearing.

Village Hall RFT – Next Steps

Stolzenburg plans on putting the design work out to bid once it is completed. He hopes that the design work will be ready by the end of April. This would provide more information on the costs of the project.

Need to find a new provider to mow village property. Will post in village and look for lawn care service provider.

Portage Count Animal Control

Would cost approximately \$262 in 2022. Will consider options, possibly with Town of Amherst.

Park Commission – Received an approved design that has a total cost of \$600,000. Commission is considering option for fund raising, reducing scope of the project or breaking the project up into smaller incremental options. **Leppen** asked about how the design could be reviewed.

Planning Commission – approved rezoning of the lot on the corner of County Q and Third Street.

Leppen – presented information from WTA meeting. The Stevens Point Tourism Board has suggested that every municipality enact a short-term room tax for the period for the 2023 Senior Open Event.

Implentation of ATV/UTV routes has been successful and there have been very few issues.

Leppen – Asked for an update on the Rising Star Mill art show and closing of the road.
