- 1. Tree Removal Still pending. Contractor was contacted, but did not hear back. **Leppen** will discuss getting a quote with another contractor that will be doing other work in the village.
- 2. Fire Siren Quotes for repairing and replacing the siren were reviewed. The cost of repairing the siren was quoted at approximately \$5800 and replacement would be about \$10,600. Board agreed to pursue other options.
- 3. Welton Drive Re-pavement Diamond would not be able to contribute to the cost of replacement, but would be able to assist with grading the road once it was paved. **Leppen** will follow up on the cost savings possible with Diamond doing this aspect of the work. Leppen will also ask about a quote for the end of Jerome and Third Street.
